# Town of Poetry Regular Town Hall Meeting Minutes- 6:30 p.m. June 15, 2021

# A. Call to Order - Tara Senkevech, Mayor

1. Tara Senkevech, Mayor called the meeting to order at 6:30 p.m.

1. Roll calls to confirm a quorum to proceed with all were present.

1. Pledge of Allegiance was leaded off by Council Member Terry Fowler.

#### G. Regular Agenda

- Discuss & considered action to adopt an **ordinance** establishing the office position of a part time secretary as a volunteer with amendments.
   Motion by <u>Fowler</u> second by <u>Jaffe:</u> Accepted <u>5</u> Opposed <u>0</u>
- Discuss and consider action to select a Mayor Pro Tempore
   Nominated : White & Anderson
   Simeon White was nominated by Vinson second White = Accepted <u>2</u> Opposed <u>3</u>
   Tom Anderson was nominated by Jaffe second Fowler = Accepted <u>3</u> Opposed <u>1</u>
   Tom Anderson is now the Mayor Pro Tempore
- 3. Discuss & consider making <a href="www.poetrytexas.org">www.poetrytexas.org</a> the official website with emails through wix.com (Paid for by volunteers) which is up in six (6) months. Kevin Senkevech, purchaser of website explained it could be between \$75 & \$80 a month with emails and limited calendars simple to use and gifted to the town. Josh Senkevech, Tech expert, EE, CS, suggested the town council pick one of the leading cloud services for their emails, calendars because Wix outsources their emails and calendars

- 5. Discuss & consider action regarding the **resolution** to adopt a written policy to expressly permit the consideration of applications received by the Town from banks, credit unions, or savings associations not doing business in the Town's boundaries for the Town's depository.

Motion by Vinson, seconded by White; Accepted 5 Opposed 0

6. Discuss & consider action regarding the **Town Seal** for use for the official letterheads, emails, & correspondence. Volunteer paid for Creative Services for designs in packet

Motion by Jaffe, seconded by Fowler; Accepted 5 Opposed 0 Seal Option #1

7. Discuss & consider action to create **subcommittee of mayor one councilmember and attorney** with Kaufman & Hunt County judges, road commissioners, & attorneys to discuss possible inter-local agreement for road maintenance

Motion by <u>Fowler</u>, seconded by <u>White</u>; Accepted <u>5</u> Opposed <u>0</u> Motion of two (2) experts – seek Volunteer or two (2) and Council Member Anderson

Five (5) minute recess

8. Discuss authorizing <u>subcommittee</u> comprised of mayor and one councilmember to negotiate on behalf of the town and possibly bring an inter-local agreement of both Hunt and Kaufman Counties regarding law enforcement for consideration at a future council meeting.

Motion by <u>Jaffe</u>, seconded by <u>Anderson</u>; Accepted <u>5</u> Opposed <u>0</u> Amend to read Two (2) Council Members White and Fowler

9. Discuss and consider **Citizen Committee w/one Council Member** to give council recommendation for action to select a solid waste vendor(s) in our area and authorize negotiation and execution of a solid waste service agreement(s).

Motion to table this discussion to the next meeting.

Motion by Jaffe, seconded by Fowler; Accepted 5 Opposed 0

10. Discuss and consider action to select a town attorney and authorize an execution of an **engagement agreement with Messer-Fort-McDonald Law Firm.** 

Citizen: Chad West opposed to looking just to one attorney.

Citizen: Lon Akin actually thought he was signed up for something else.

Motion to table this discussion to the next meeting

Motion by <u>Jaffe</u>, seconded by Fowler; Accepted <u>3</u> Opposed <u>2</u>

11. Discuss and consider an **ordinance** for receiving franchise fee from Oncor Electric.

Citizen: Lon Akin, franchise fees will increase billing for the citizens.

Oncor guest: Cindy Tatum spoke to the council about a franchise fee (a part of doing business - \$0.003589 per kwh average residents being 1,300 kwh/mo.

Motion to recess for 2 minutes while Mrs. Tatum made a phone call about back charging residence's – the answer was no there would not be a retroactive charge. Motion to accept and pass by <u>Anderson</u>, seconded by <u>White</u> subject to legal review; Accepted <u>4</u> Opposed <u>1</u> Fowler

12. Discuss and consider an **ordinance** for receiving franchise fee from FEC electric.

Motion to table discussions about FEC until next meeting

Motion by <u>Jaffe</u>, seconded by <u>White</u>; Accepted <u>5</u> Opposed <u>0</u>

13. Discuss and consider the **quote** received from TML risk insurance for the Town, council and volunteers.

Motion by Fowler, seconded by Jaffe; Accepted 5 Opposed 0

14. Discuss and consider **50-year Commercial Lease Agreement** with the Camp Ground Church as written.

Citizen Chad West – doesn't think the city will be able to pay for this

Citizen Lon Akin – worried about 20 years down the line and indifference between the town and citizens.

Motion for the Mayor and Council Member Vinson to re-evaluate the lease Motion by White, seconded by Fowler; Accepted 5 Opposed 0

#11 Item reopened up for discussion was Oncor Electric. Motion by Jaffe
The rates across the state are the same. There will not be an increase in bills

17. Discuss and consider date, time, and location of regular Town Council meetings. Amendment for Third Tuesday of every month at 6:30 p.m. at Faith Temple Baptist Church.

Motion by Fowler seconded by Vinson; Accepted 5 Opposed 0
