- d) Invocation CITIZEN COMMENTS: Persons wishing to speak on any posted agenda item may do so when the individual item is opened for consideration by the Council. Speakers will be limited to three (3) minutes unless a longer period of time is allowed by law for use of a translator. Persons wishing to speak must sign up at least 24 hours in advance of the meeting by emailing <u>contact@poetrytexas.org</u> or by signing up in person at meeting location from 6-6:30 pm with name, address and agenda item on which to there is a desire to speak. You must be signed up to speak during the meeting. Comments should be respectful with no personal attacks. To preserve the order and decorum of meeting of the Town council, any person who makes, profane, slanderous or threatening remarks or who becomes disruptive during the meeting will be asked to leave the Council Chambers. (Loc. Gov. Code 38.13, 42.05)

e) Items of Community Interest

Pursuant to Section 5510415 of the Texas Government Code, the Town Council may report on the following items: 1) expression of thanks, congratulations, or condolences; 2) information about holiday schedules; 3) recognition of individuals; 4) reminders about upcoming Town Council events; 5) about community events; and 6) announcements involving imminent threat to public health and safety.

h) Regular Agenda

- 2) Discuss and consider the Ordinance for Emergency Management Services for Poetry.
- 3) Citizens Committee for Solid Waste Solutions to report on their research and recommendations. Questioning and discussion about recommendations.
- 4) Discuss and consider the Ordinance for Solid Waste Collection in our Area.
- 5) Discuss and consider the engagement contract of Messer, Fort & McDonald PLLC as written.
- 6) Discuss and consider growth in the area and potential need for managing that growth. Consider and take appropriate action regarding the formation of a Planning and Zoning Commission, membership, and next steps for zoning regulations.
- Discuss and consider any needed modifications to the October 1, 2021-Sept. 30^{th,} 2022 budget. Changes are in color.

8) Discuss the Referendum needed for the Sales and Use Tax with deadline mid-August to be put on ballot as follows.

"The adoption of a local sales and use tax in Town of Poetry, Texas at the rate of 2 percent (2%) to provide revenue for maintenance and repair of municipal streets."

j) Adjournment

The council may go into closed session at any time when permitted by Chapters 418 or 551, Texas Government Code, or Section 321.3022 of the Texas Tax Code. Before going into closed session, a quorum of the Council must be assembled in the meeting room, the meeting must be convened as an open meeting pursuant to proper notice, and the presiding officer must announce that a closed session will be held and must identify the sections of Chapter 551 or 418, Texas Government Code, or Section 321.3022 of the Texas Tax Code authorizing the closed session.
