Synopsis of Regular Meeting, Thursday April 18th, 2024 held at Town Hall:

 Mayor gave March End Report, Sales & Use Revenue Report, and Q2 Budget Vs. Actual Report.

Consent agenda items:

- Approved minutes for March 21st & March 27th meetings
- Approved paying legal bill of 1365.00
- **Approved** TML annual renewal of \$812 and Insurance renewal of \$1039.
- Approved 18 ETJ petition releases.
- Approved Ordinance 2024-03-01 in final form with newspaper announcement.


Regular Agenda:

- Denied TES Big Rack Ranch ETJ petition removal for legal reasons. Denied Bishop Field LLC. ETJ petition removal for legal reasons.
- **Approved** Chad Dalida/365 Development ETJ petition removal.
- **Decided** to form an ad hoc committee comprised of CM Fowler and CM Anderson to communicate with the town's engineering firm regarding map questions.
- **Discussed** results of surveys and keeping Poetry Street names the same but considered adding a "historical reference" to roads such as "League Line Rd" added to the poles.
- Approved Ad Valorum Restriction Ordinance.
- **Discussed** trying to develop a fair policy for dead removal. Decided to get quotes on tree removal for safety issues.
- **Discussed** needing warranty contract information and recommendation from engineer before purchasing Street Dynamics Solar-powered device for providing data for potential grant applications. Constable Johnson upon hearing the item, offered to "loan" their data collection unit free of charge to the town when it is not being used.
- **Discussed** the cost of checking ETJ removal survey checks at \$75 each.

Meeting adjourned at 9:46 pm.

LEGAL NOTE: A TYPE A General Law Town such as the Town of Poetry with no utilities **never has had the ability to forcibly annex** properties. Only Home Rule towns and those with utilities had that capability. HB 347 greatly reduced the ability of **any** city from forcibly annexing.

Concerned about your family's descendants selling out to just any developer? Idea: Ask for your will and warranty deed to have specific deed restrictions prior to selling.
