



Residents frequently ask whether City zoning laws and proposed zoning changes override deed restrictions. The question often centers on whether a multi-unit residential structure can be built on a lot, even if the lot is subject to deed restrictions that limit development to a single residential unit. (These restrictions should not be confused with regulatory covenants required by the City, which are commonly referred to as "public restrictive covenants.")

Connect

The short answer is that the Land Development Code does not affect the enforceability of deed restrictions. Several things to keep in mind regarding the Code, City zoning laws, and deed restrictions include:

- Deed restrictions are a civil matter enforced by the parties named in the restriction, such as a property owners' association
 or a property owner.
- Changes to city zoning regulations should not affect the enforceability of deed restrictions. A deed restriction that is
 enforceable now should continue to be enforceable, regardless of changes to City zoning regulations.
- · Zoning does not extinguish the obligations between parties to a deed restriction.

Other questions focus on whether the City can deny permit applications based on deed restrictions that exist on a property. Several things to keep in mind regarding City permit application approvals and deed restrictions include:

- If a building permit application complies with the Land Development Code, then staff must approve the application whether
 or not it conforms to a deed restriction.
- The City cannot prevent landowners from developing property based on a deed restriction.

Although the City cannot enforce deed restrictions, the City has updated its residential permit application form that requires the applicant to acknowledge the following:

- The applicant has checked for any property-specific information such as deed restrictions or restrictive covenants on the property.

 - 1) Mayor Tara Senkevech opens with the reading of a legal statement: "Upon the Town's determination as to the most qualified applicant. The Town will then negotiate pricing and fee structure. If the Town and the most qualified applicant, owner, and legible to negotiate an acceptable resting at fee structure. The Town will then proceed to negotiate with the next most qualified applicant. And so on until a final selection is made."
 - 2) Mr. Ray Bramley of Exceed Engineering gives his presentation, followed by some Q & A from City Councilmembers.

- 3) Discuss and take action on finalizing Solid Waste Addendum B: Non-exclusive for Roll-offs Solid Waste Franchise Agreement.
 - Discussion was had regarding entering into a one-year contract and reevaluating their performance after one year. The contractor is to keep a log of all complaints, including their resolution, and report them back to the Town monthly. Change the availability by phone for the Town from 7:00 am-7:00 pm to 8:00 am-500 pm. Fees against contractors for violations were also discussed. Citizen Doug Kindred spoke with some questions about the trash cart that they would be receiving and how that affected bulk pickup and using garbage bags.

4) Discuss and take action on four culvert replacements on CR 2464 on Project Sheet H-09 for \$8,250.00 for materials cost only. This discussion item is regarding four potentially culvert replacements on CR 2464. This item was tabled for councilmembers to have the time to look over the locations of replacements and a potential second area at CR 2446. Additionally, to explore the possibility of breaking this item down into multiple, individual items in the future. No motion is needed.

- 5) Discuss and take action to have agenda items author and supporters' names attached at the end of each item [CM Fowler and CM Jaffe]: This agenda item proposes adding the names of councilmembers who requested specific agenda items to the monthly agenda, allowing citizens to contact the relevant members. It was decided to include the "requester or requesters" name in parentheses at the end of the specific agenda item. Motion by Councilmember Mike Jaffe, seconded by Councilmember Tom Anderson. Passes 5:0
- 6) Discuss and take action on the proposed concrete crushing plant on Hwy 276. Councilmembers Jonathan Blake and Simeon White raised concerns about the proposed concrete crushing plant. Mayor Senkevech had consulted Poetry's legal counsel, who clarified that since the plant is outside Poetry's jurisdiction, the town has no authority over the matter. An upcoming meeting on Wednesday, December 27, 2023, at 10:00 am at the Hunt County Commissioners Court will provide an opportunity for residents to voice their concerns. Citizen Doug Kendrick shared his experience, highlighting limited options for neighboring towns. Citizen Glen Strauss, drawing from past employment at a concrete plant in California, expressed concerns about the dust generated. No motion is required.
- 7) Discuss and take action on Councilmember Fowler's petition to release from ETJ: Mayor Tara Senkevech highlighted compliance with state law, noting that, in the event of a conflict of interest, an Affidavit of Disclosure had been filed and has been submitted to the City Secretary. Legal counsel has advised that Councilmember Terry Fowler cannot address this matter during the meeting. Councilmember Mike Jaffe expressed concern about such issues handled through a council meeting and voting. Mayor Senkevech explained that due to the unique nature of the Town of Poetry, requests to be released from the ETJ require a council vote. Councilmember Tom Anderson observed that none on the council are land surveyors, lacking specialized qualifications. Councilmember Simeon White suggested handling these matters outside of the council, involving an engineer, and bringing them to the council only if issues arise. Mayor

Mayor Senkevech stressed the need for thorough ongoing research, emphasizing that attempting to extract land located in Poetry proper would invalidate the request. The Council acknowledges increased information in the forms and legal counsel's review and is currently willing to continue approving or denying requests until a town surveyor is on board.

Citizen Amy Fowler spoke explaining the wish to remove their land from the ETJ. Citizen Kevin Senkevech expressed displeasure, deeming Councilmember Fowler's request unbecoming, and argued that the Texas bill Mrs. Fowler referenced wasn't intended for towns with less than 20,000 occupants. Senkevech reminded the council of Fowler's previous desire to extend map lines to include his property and now wanting removal from the town. He requested Fowler withdraw his petition or step down as a Town Councilmember and asked the sitting Council to reject Fowler's request to be removed from the ETJ. (there were background interruptions from a member of the audience during this time and had to be admonished by Mayor Senkevech). Motion by Councilmember Simeon White, seconded by Councilmember Jonathan Blake. Passes 3:1 Mayor Tara Senkevech read a prepared statement which included, "I waited until after the vote on this matter to make my statement so as not to influence the vote. As the chair of this Council, I believe it is my duty to express that a sitting Councilmember intentionally using personal funds to remove their property from the town they serve is against our decorum and procedure policy. Resolution 2021.1001R emphasizes the obligation of elected officials to uphold high moral standards and prioritize the public interest over personal considerations. Councilmembers must show unconflicted loyalty to the entire town. Mr. Fowler's actions violate these standards, placing personal interests above the town's interest. I publicly admonish him for this unethical violation, expressing the hope for the best for him and each Councilmember."

Wind speed is another contributing factor to distance traveled: as wind speed increases, so does the distance traveled of the respirable dust particles.

The following tables demonstrate the relationship between particle size, wind speed, and distance traveled:





Clearly, the smaller the particle the further the distance the dust particle travels, especially in an environment with stronger winds. While these are average distances, this phenomenon illustrates how pertinent it is for proper engineering controls to be in place when it comes to suppressing silica dust. Failing to properly control silica dust affects not only the construction crew, but people in the surrounding areas-in some cases as far as 50 miles from the site.
